An introduction to LSCP training

Who is eligible to attend training?

You must work or volunteer with an organisation that provides services to children and/or their families who live in, or who are looked after by, the London Borough of Lambeth.

How much does it cost?

All our training is free to access provided that you meet the above eligibility requirements.

Who delivers the training?

Some of our courses are delivered by an LSCP trainer, others are delivered by external trainers. Please check the course description for more detail.

What different types of training do you offer?

To accommodate diverse learning styles and requirements, we provide 3 different approaches to training and learning:



E-learning

- Our E-Learning modules provide the opportunity to learn about Level 1 and Level 2 Safeguarding topics at your own pace and during your own time. Certificates are available upon completion.



Level 3 Training

- Our Level 3 training offer provides interactive and reflective opportunities to learn in a structured and facilitated space delivered by a trainer. Certificates and course materials are available upon completion.



Self-guided Learning Resources

- Our self-guided learning resources can be used to learn and reflect in your own time and in practice, for example, as a supervision prompt. These are available on our website and do **not** come with certificates.

 What are the training levels?

Level 1

- **Introductory courses**
- Cover basic safeguarding content. You will gain knowledge on what safeguarding is and explore how to recognise signs and symptoms of abuse and neglect, and also how to report your concerns.
- They are aimed at people **who come into contact with children and/or their parents carers**. For example, receptionists, volunteers and local authority staff.

Level 2

- **Intermediate courses**
- Cover basic safeguarding content in more depth, like how to report and respond to concerns.
- They are aimed at people **who have a duty of care towards children**. For example, youth workers, teachers, social workers and early years practitioners.

Level 3

- **Advanced courses**
- Cover key safeguarding topics in more details, like how to respond to specific types of harm and develop the skills needed to safeguard children.
- They are aimed at those **who are in a position of management or responsible for making key decisions with regard to safeguarding children**, like contributing to multiagency safeguarding responses. For example, safeguarding officers, nursery managers, GPs, headteachers, local authority staff and VCS Leads.

Level 4

- **Specific to role**
- Bespoke training and recommended training from safeguarding practice reviews, national reviews and learning practice reports. These are Level 4 courses that are suitable for safeguarding champions that will ensure the learning is cascaded in their organisations.
- We do not include these within the training programme as these are targeted offers.

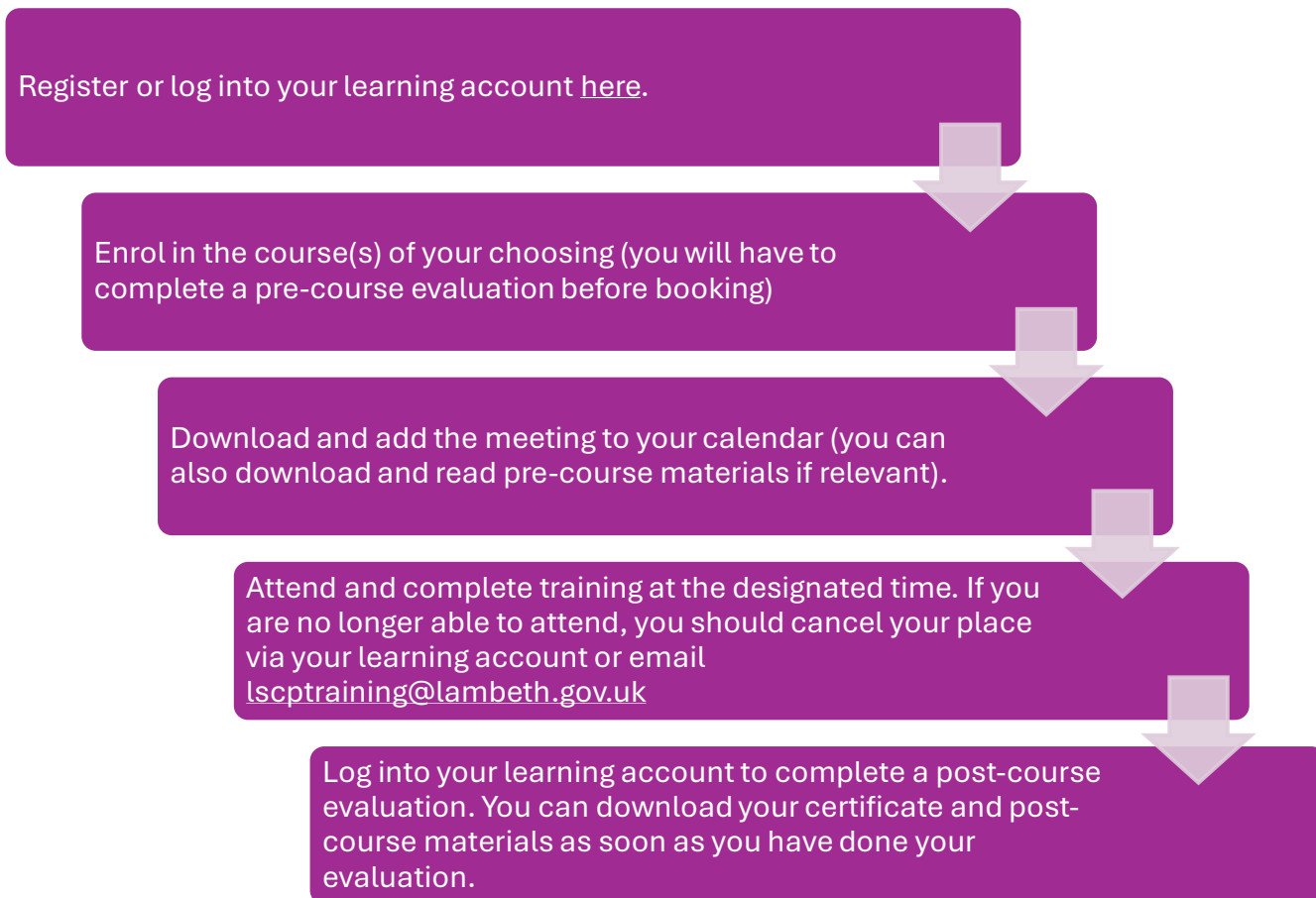

Who should attend? (*Target audience*)

Anyone who works or volunteers with children and families living in, or looked after by, Lambeth is encouraged to attend, particularly those who complete safeguarding referrals and assessment, or contribute to multiagency working.

Why should they attend? (*Course aims*)

The training will help you to understand how racism and bias can adversely impact safeguarding responses and develop the skills to explore and address these issues when working with children and families.

What will they gain? (*Course objectives*)

By the end of the course, you will be able to:

- Identify the origins of race and racism
- Recognise how racism can manifest into dangerous safeguarding practice and the impact for children and families
- Understand what is meant by intersectionality and the importance of curiosity about all elements of child and family identity
- Apply critical thinking skills when considering how intersectionality and oppression can translate into increased risk of harm to children
- Understand how cultural competence can strengthen responses to children and families and identify practical ways to balance cultural sensitivity and challenging harmful behaviour
- Identify creative approaches to removing service access barriers and create conditions to encourage engagement

🔍 Why should they attend? (*Course aims*)

The training will help you to recognise the signs of child sexual abuse in the family and improve your confidence to respond.

By the end of the course, you will be able to:

- Describe the different ways which children can be sexually abused in the family and the prevalence of this type of abuse
- Explain why children find it difficult to talk about sexual abuse and how to recognise indicators of sexual abuse
- Be more confident to respond to disclosures of child sexual abuse
- Understand how abusers operate and develop knowledge of the models of grooming
- Identify the impact and role of non-abusing parents
- Describe what needs to be considered when assessing and responding to child sexual abuse
- Explain what local support pathways are available for children

Multi-agency safeguarding

✓ Who should attend? (*Target audience*)

All staff and volunteers who make key decisions in regards to safeguarding, including safeguarding referrals and multi-agency working, should attend this training. This training should be undertaken at least every 2 years by safeguarding leads and every 3 years for other staff with responsibilities at level 3 competency.

🔍 Why should they attend? (*Course aims*)

The training will help you to develop the knowledge and skills to identify, assess and respond to safeguarding children concerns in line with Working Together To Safeguard Children.

📖 What will they gain? (*Course objectives*)

By the end of the course, you will be able to:

- Describe the legal framework for safeguarding children and associated duties
- Define the different types of abuse and neglect children can experience
- Recognise the indicators of abuse and neglect
- Explain how to respond to disclosures or indicators of harm with professional curiosity
- Identify the thresholds for action and different levels of response
- Apply critical thinking and risk analysis skills to indicators of harm to inform responses and referrals
- Define what constitutes a good quality referral to Lambeth children's social care and explain what happens after referrals are made
- Recognise the challenges of multi-agency working and the adverse impact this can have on safeguarding responses
- Develop best practice approaches to multi-agency working and information sharing
- Recognise the importance of professional challenge and explain how to escalate concerns

Navigating adult needs and behaviours in child safeguarding

✓ Who should attend? (*Target audience*)

This training is ideal both for people who work with vulnerable adults and for people working in roles with safeguarding duties to children.

🔍 Why should they attend? (*Course aims*)

The training will help you to develop your knowledge around how adult needs, vulnerabilities and behaviours can impact the safety of children and develop the skills to effectively assess and respond to adults to achieve better outcomes for children.

📺 What will they gain? (*Course objectives*)

By the end of the course, you will be able to:

- Define what legal duties are attached to parental responsibility and what constitutes 'good enough' parenting
- Identify a range of factors that can adversely affect parenting ability and describe the potential impact for children
- Understand the common challenges when working with vulnerable adults and how this can lead to dangerous child safeguarding practice
- Apply critical thinking skills when identifying and assessing whether adult vulnerability needs a child safeguarding response and
- Describe how to respond when adult vulnerability increases risk of harm to children
- Identify when adult behaviours and responses to offers of help and support increase the risk of harm to children
- Describe and apply best practice approaches when working with 'hard to engage' adults.

Prevent Duty

Trusted Youth Allies

Who should attend? (*Target audience*)

Anyone who works or volunteers with children who are affected by crime.

Why should they attend? (*Course aims*)

As part of MOPAC's statutory responsibility to ensure support is available for victims of crime in London. Trusted Youth Allies is designed to train trusted adults, those who may receive disclosures from young people affected by crime, particularly when those young people choose not to report incidents to the police. 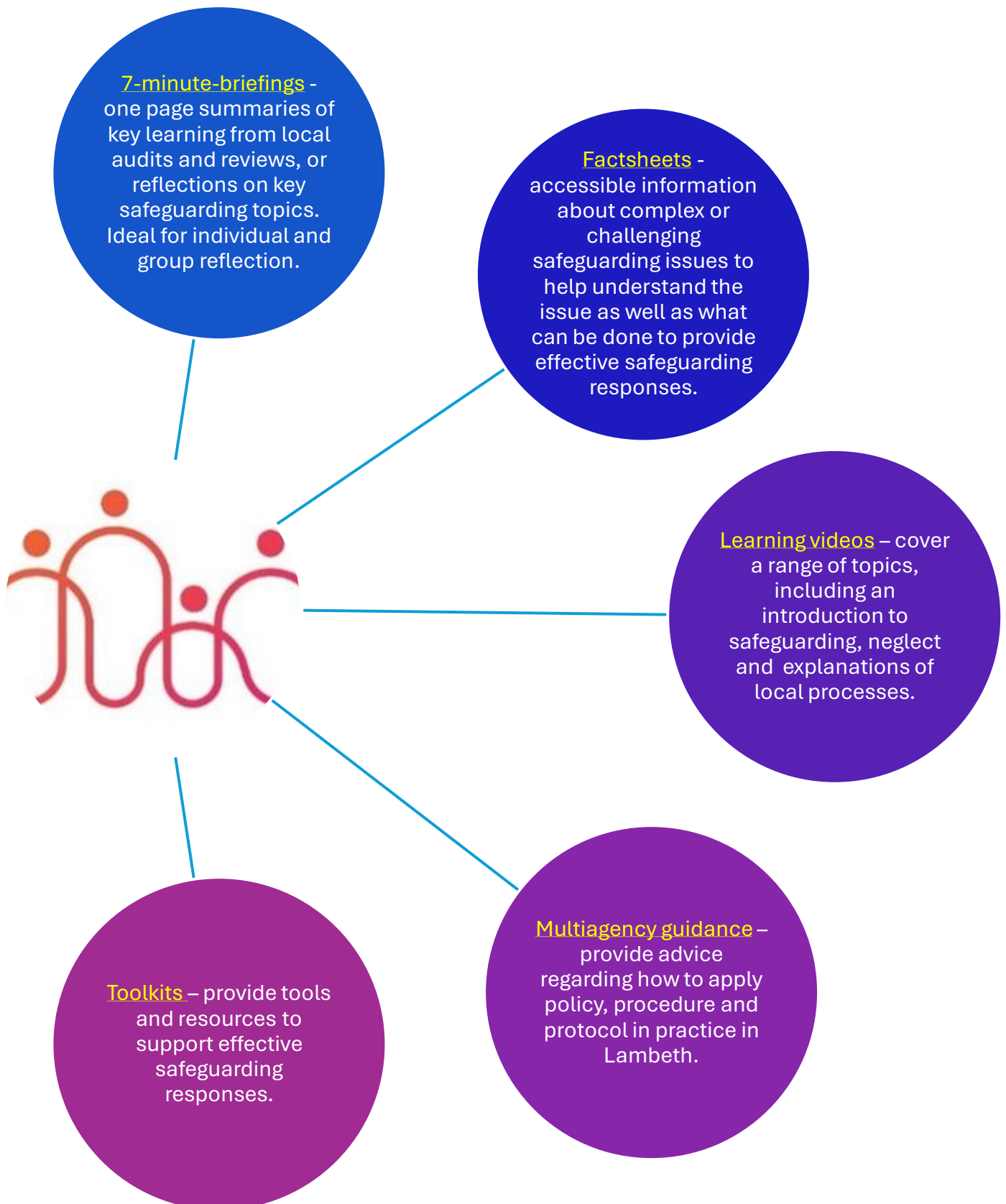
